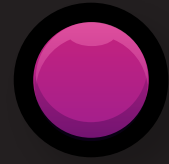

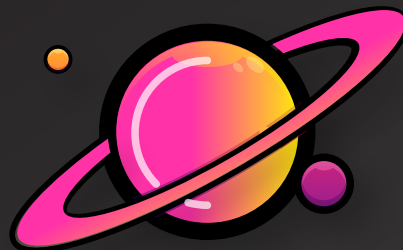

HOW IT WORKS

Buy your ticket: Use your favorite cryptocurrencies to buy tickets. We offer a unique integrated swap function that supports most common coins, across chains like Ethereum, Solana and Polygon. Available at launch; your crypto automatically gets converted into our native \$BOOST token, which resides on the Elysium blockchain. Enjoy a hassle-free entry into our lottery!

Are you new to crypto? We will offer an extensive guide to set up your wallet, get some funds in there and participate in the BOOST lottery. Need more support? Our staff will be available for support using chat, email or any of our other communication channels. Additionally, direct FIAT payments are in the pipeline and will be supported too in the future.

BOOST your chances and winnings: Once you're in, BOOST your ticket with up to three LUCK BOOSTERS to increase your chance to win, and up to three WEALTH BOOSTERS to potentially multiply your rewards by up to 10.000x.

You can buy BOOSTERS on the spot, after which they will reveal your multiplier on either LUCK or WEALTH. Not satisfied with the multiplier? You can purchase new ones until you are. Simply stick them on your ticket to BOOST your win chance and/or the potential prize you can win!



BOOSTERS trading: To get BOOSTERS, either buy them directly and reveal their multiplier yourself, or buy them from other players who already revealed the multiplier in our marketplace. This enables you to pick up specific multipliers that match your already owned BOOSTERS, enriching chance with strategy. All trades in our marketplace feature low fees and short confirmation times!

Draw Time: When you're satisfied, have picked your lucky numbers and BOOSTED your ticket, it's time for live fireworks! In our livestream Draw Show, everybody gets front row seats and can watch our lottery draws take place.

During these fun live shows, our participants get a chance to win unique giveaways, including free BOOSTERS, goodie bags and much more!

Our INSANE DRAWS will feature 3 winners:

- **1st** place: this is the absolute WINNER of the round, with a whopping 60% of the prize pool being handed out to this player – Truly the stuff of dreams!
- **2nd** place: this is no reason to be bummed, because second place rakes in a whopping 30% of the pot, making this a winner in its own right!
- **3rd** place: our 3rd place winner receives the remainder of the pot, which is nothing to scuff at. Ending up with 10% of the total winnings is pretty amazing if you ask us.

A CLOSER LOOK AT OUR BOOSTERS

BOOSTERS are the add-ons for tickets that players can buy, trade or win, each one with a multiplier to your LUCK or WEALTH. They behave the same as scratch cards; players won't know which BOOSTER multiplier they receive upon purchasing and they need to activate it through a fun interaction to discover its details.

After a player buys a (closed) BOOSTER and decides to open it, the corresponding LUCK or WEALTH factor is revealed. On special select events, BOOST Lottery can sell or give out WEALTH and LUCK BOOSTERS with undisclosed multipliers to spice things up even more for the participants.

BOOST Lottery will offer the following BOOSTERS for sale:

REGULAR LUCK BOOSTERS

LUCK BOOSTERS increase a player's chance to win a prize, with a max of 3 LUCK BOOSTERS than can be applied to any ticket.

REGULAR WEALTH BOOSTERS

WEALTH BOOSTERS contain a multiplier that gets applied to the initial prize won by a player, with a max of 3 WEALTH BOOSTERS per ticket.

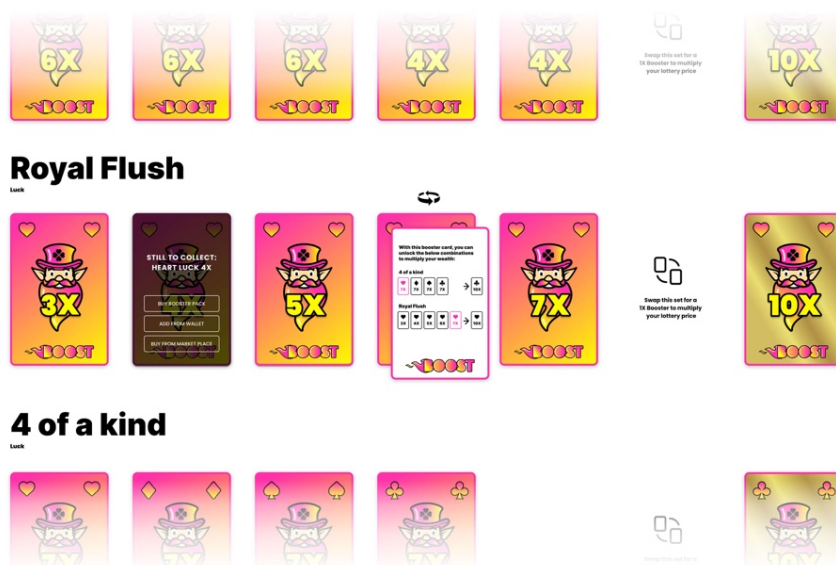

TOKENOMICS OF \$BOOST

BOOST Lottery will mint the \$BOOST token, with a hard cap of 1B tokens, of which 25% is allocated to three rounds of presales.

PRESALES

The allocation of 250M \$BOOST tokens available for presale purposes will be advertised in three rounds to seed investors, private sale participants and via public sales to any interested parties if there's allocation left.

Below is the targeted breakdown per round, visualized for convenience.

VESTING SCHEDULE

The Vesting schedule is outlined below. The lockup period is calculated from the Token Generation Event (TGE), which is planned after the public sale has been concluded which is planned for July.

After the lockup period has ended, the remaining vesting cliff % will be distributed in equal parts every month following. Below schedule outlines the distribution.

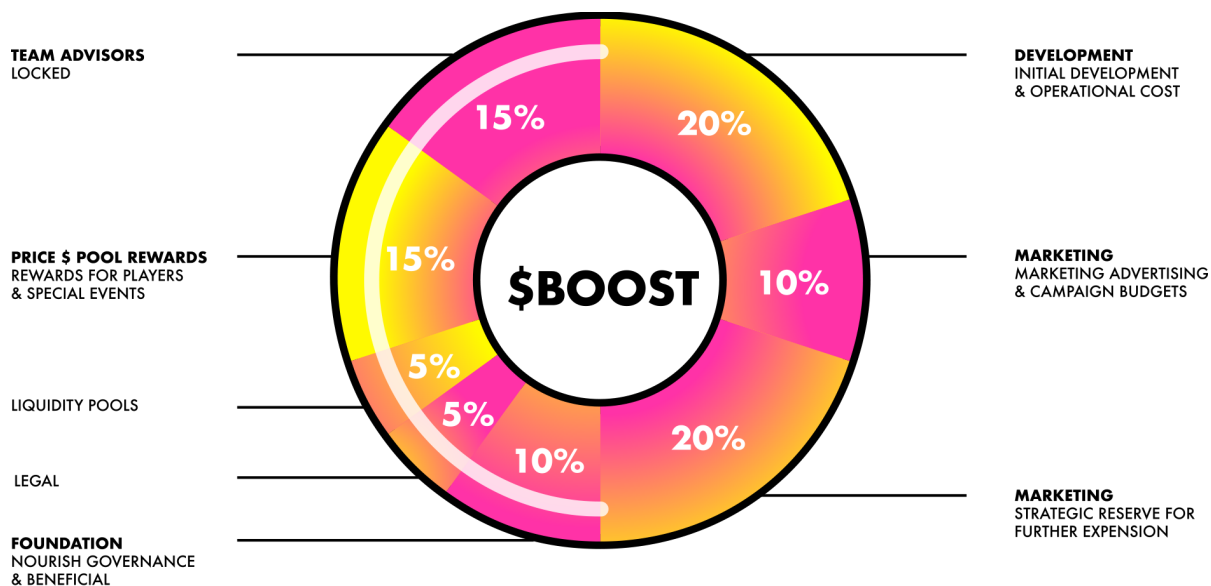
MAIN SUPPLY

After presales have concluded, a total of 750M \$BOOST tokens remain.

BUYBACK

A portion of the proceeds will be allocated towards buying back \$BOOST at strategic moments in time, ensuring a healthy token valuation for \$BOOST. The height of the buyback will be determined on a draw-by-draw basis, calculated on parameters such as realized ticket sales, current prize pool reserves, realized BOOSTER sales and more.

BURNING

For each buyback happening, 5% of those \$BOOST will be burned to make the token deflationary, attributing to the valuation of the \$BOOST token and to mitigate excessive circulating supply moving forward in time. BOOST Lottery reserves the right to change the amount burned under specific circumstances.

COMPONENT OVERVIEW

- **Elysium Blockchain**
BOOST Lottery will be utilizing the Elysium Blockchain as its underlying technology. Elysium, a Layer 1 (L1) blockchain, is specifically designed for the iGaming industry, focusing on speed and stability to ensure safe and rapid transaction processing.
- **Wallet Integration**
For wallet integration, BOOST Lottery plans to collaborate with leading wallet providers through RainbowKit and WalletConnect. This integration will support a broad array of major wallets and blockchains, ensuring comprehensive compatibility and user accessibility.
- **Cross-Chain Transactions**
The BOOST Lottery platform will incorporate a Unique Swap feature, using the Wormhole network to facilitate cross-chain interactions. This feature will enable users to deposit their preferred cryptocurrencies and simultaneously receive \$BOOST tokens on the Elysium blockchain, streamlining the transaction process for experienced cryptocurrency users.
- **Front-End Technology**
The front-end user experience of BOOST Lottery will be powered by the latest in web3 technology combined with industry standard web2 frameworks. These technologies are recognized as the standard in the industry for developing scalable and responsive web applications, particularly in the Web3 space and are battle-hardened. This combination is chosen for its effectiveness in delivering a seamless and user-friendly interface.
- **Back-End Architecture**

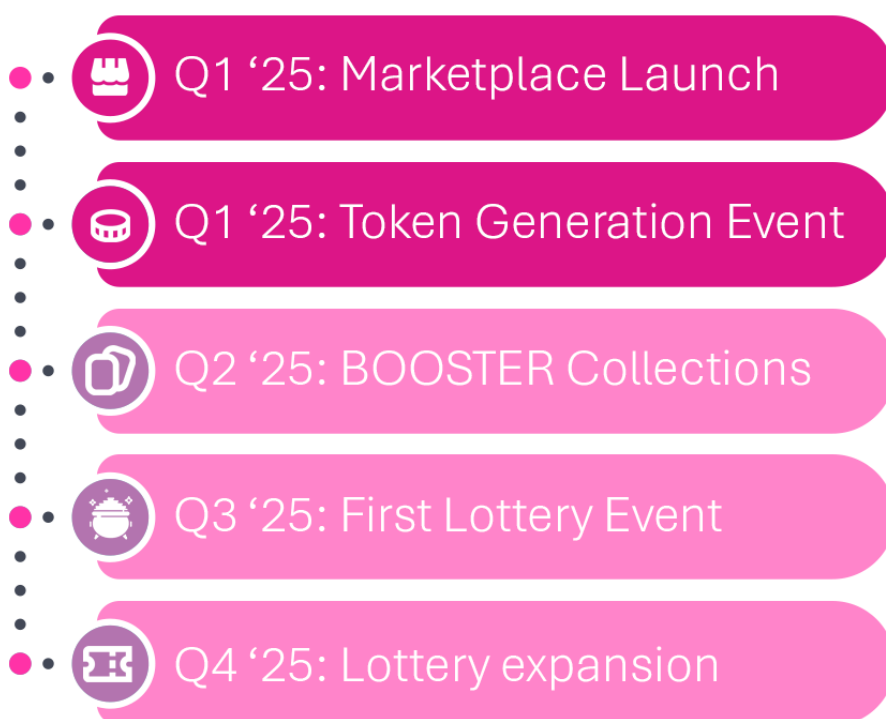
